Subject: Price Benchmarking of non-torrefied Biomass Pellets for National Capital Region (NCR)- reg.

Sir/Madam,

I am directed to refer to this Ministry's letter of even number dated 03.10.2024 regarding Price Benchmarking of non-torrefied Biomass Pellets for NCR whereinthe benchmark price for biomass pellets for NCR was specified as **Rs 2.32/1000 Kcal** without GST & transportation, valid up to 31.08.2025 (i.e. for a period of 1 year).

- 2. In this regard, the Committee on Price Benchmarking of Biomass Pellets has further decided that the benchmark prices for non-torrefied biomass pellets in the NCR may continue to remain same as **Rs. 2.32/1000 Kcal** up to 31.08.2026 i.e. for a further period of one year. The price specified is excluding GST & transportation cost at the pellet manufacturing plant site. The pellets shall have moisture content below 14% and GCV between 2800-3400 kcal/kg.
- 3. The concerned TPPs may be advised to adhere to the above-mentioned benchmark price of non-torrefied biomass pellets and to take necessary action accordingly.
- 4. This issues with the approval of Hon'ble Minister of Power and Housing & Urban Affairs.
